It has been another busy and fulfilling year for the Council's Environmental, Planning and **General Purposes Committee** and yet again we have seen an increasing number of planning applications being considered. Many of these have been from Meltham residents and businesses seeking to improve and enlarge their properties. As a committee we have been pleased to see that many of these improvements enhance individual properties as well as

improve our Township.

Like much of the country we have started to see the impact of the increasing optimism in the housing market. Whilst this increase in activity may not have resulted in any significant increase in house prices or new housing sites started, particularly in the Township, there has been increased activity from house builders seeking both new and revised planning permissions. Of course this is a 'double edged sword' for us. Firstly the prospect of greater building activity may lead to sites such as Albion Mill and Brook Dyeing being finally developed, removing these current 'eyesores', with more choice of new housing and even possibly some 'affordable' housing, as well as more economic activity and employment for local people. However, secondly there has also been a number of planning applications on other more controversial sites, such as the 'Pink Link' site at Crosland Mills, fields at Colders Lane and Helme Lane. The Town Council has objected strongly to the development of all these sites on various grounds, including traffic management, overdevelopment, not enough affordable housing and the loss of valuable green space. However, this is likely to be a losing battle, as Kirklees Council's Planning Committee is minded to approve all of them, because they are sites that match current national planning policy. Regrettably if Kirklees doesn't approve them they will be heavily fined by Central Government!

The 'BIG ISSUE' for local residents and the Town Council fortitude during the past year. is Central Government's current Planning Policy on house building. Your Town Councillors, like many of the town's residents, are increasingly frustrated that local voices are not heard in the planning process. This is because national government policy overrides local

concerns. In the last few years many residents took part in the public consultation for the strategic plan for the Kirklees area, the 'Local Development Framework', or LDF as it was called. This plan shockingly identified that a further 500 houses would have to be built in and around Meltham over the next 15 years. Kirklees Council approved this plan despite strong objections by both local residents and the Town Council on the grounds that the 500 figure is both excessive and in danger of totally changing the unique character of the Township. It is fair to say that all other similar communities in Kirklees were also required to have built similar numbers of houses. Incredible as it may seem, Central Government has rejected the Kirklees LDF on the grounds that not enough housing has been identified and the plan has been forced to go back to the drawing board. This means that there is a high risk that substantially more housing will be required to be built in Meltham, which can only be built on green fields, as there are no 'brown field' sites available. It is clear that National Planning policy is too heavily in favour of Westminster led views. This current government policy is an attempt to achieve a huge increase in house building in every town and village in the country, and takes little or no account of local demand or local environmental concerns. On this 'big issue' your Town Councillors will continue to vigorously object and fight for a change in planning policy so that communities, like ours, are protected from excessive over development. Some housing and in particular increasing numbers of affordable housing makes sense, but substantial increases to the size of townships, like Meltham, we believe makes no sense! Finally, my fellow Councillors and I believe strongly in the openness of your Town Council. We positively

welcome you to our meetings should you have either a concern with a planning application or a wider concern with the environment in the Township. Your views and concerns are an important part of shaping the committee's decisions.



This is my first foray into Chairing the Finance Committee of Meltham Town taken over from a very worthy Clr Holroyd-Doveton.

Meltham Town Council has had to cope financially with the continuing budget cuts imposed firstly by the Government which have then impacted on Kirklees the Committee for the forthcoming to make.

On the brighter side, the Robert Ashton Memorial Park, whilst still incurring the largest expenditure for the council, has seen the renovation pitch. Our current landscape gardener in the park has made a vast improvement to the planting and grass cutting and overall the look of the driveway.

The Holme Valley Mountain Rescue Team headquarters which were going to be situated in the park have now fallen through with the headquarters Council over the last financial year having remaining at Marsden. However, one of our Councillors came up with the idea of moving the Scout & Guide Headquarters into the park on the HVMRT site with a new purpose built headquarters. The original scout hut would be sold off as building land to hopefully to create sufficient revenue to build the new headquarters with a surplus.

2013 - 2014

Total grants given to the community this year totalled £39,313. Council and then us.
